Regular City Commissioner Meeting Minutes, Crab Orchard City Hall Aug 1, 2019

The meeting was called to order at 6:32 by Mayor Billy R. Shelton; Mayor Shelton led the invocation and led everyone in reciting the Pledge of Allegiance to the US Flag.

Role call was performed by City Clerk; all were present for meeting, Mayor Shelton established there was a quorum.

Last month's meetings minutes were reviewed and no changes needed to be made, Commissioner Keith Saylor made the motion to accept last month's minutes as stand, 2nd by Commissioner Mile Eldridge, all in favor, motion carried.

Financial report was given by City Clerk (see attached), no changes need to be made, and Commissioner Kenneth Manuel, made the motion to accept as stand, 2nd by Commissioner Mike Eldridge, all in favor, motion carried.

Commissioner Reports

Emergency Service Commissioner Kenneth Manuel reported Police Chiefs, Jimmy Gipson's report (see attached). 4 complaints, 1 investigation, 0 arrest made, 2 traffic citations, 7 traffic stops, and 4 domestic.

Water/Wastewater Commissioner Keith Saylor reported the water loss is 10%, he also reported Water Superintendent's Devon Shelton's monthly water report (see attached). Reported on status of main lift station, we have the pumps pulled and are being repaired. The pumps were full of solids and we need to establish a monitoring and maintenance daily program for the lift station.

Streets and Road Commissioner Mike Eldridge reported, have not heard back from Adam from Kentucky Utilities regarding the extra street lights we want to install at end of town and Meadowlark Subdivision.

City Commissioner Bill Dyehouse requested a breakdown for the mulching on City Park. City Clerk will request one from Pingleton Lawn Care for the \$900.00 invoice.

Mayor Shelton reported we have purchased a lawn mower from Marks Feed for the amount of \$3900.00 it is an Ex-Mark brand.

New Business:

Discussion for the property tax rate, Commissioner Keith Saylor made the motion to accept rist reading on ordinance #19-08-01 taking the compensating tax rate in the amount of 12.7 cents per \$100.00 with the anticipated revenue of real property of \$24,319.62. The personal property tax rate will also be the compensating rate of 12.4 cents with estimated revenue of \$1132.80, 2nd by Commissioner Bill Dyehouse all in favor motion carried.

ORDINANCE #19-08-01 SETTING 2019 CITY OF CRAB ORCHARD TAX RATES ON REAL AND PERSONAL PROPERTY

WHEREAS, the City of Crab Orchard must set tax rate prior to September 8th 2019 for the 2019 tax year.

WHEREAS, the City of Crab Orchard must ensure that is it able to meet the rising cost associated with the operation of the city.

WHEREAS, KRS 83A.060 states the procedure for the amendment and/or enactment of ordinances:

BE IT ORDAINED BY THE CITY OF CRAB ORCHARD MAYOR AND COMMISSIONERS AS FOLLOWS:

Section 1

The real property tax rate for the 2019 tax year shall be set at a rate of 12.7 per \$100.00 (one hundred dollars) of the assessed value of said real property with an anticipated revenue of \$24,319.62

Section 2

The personal property tax rate for the 2019 tax year shall be set at the compensating rate of 12.4 per \$100.00 (one hundred dollars) of the assessed value of said real property with an anticipated revenue of \$1132.80

Section 3

That there will be a 2% discount for all taxes paid before November 1st 2019 and a penalty for all taxes paid after December 31st 2018.

Section 4

That the tax rate from the preceding year for real property was set at .129 (12.9 cents) per \$100.00 (one hundred dollars) with an anticipated revenues of \$24,315.13.

Section 5

That the tax rate from the preceding year for personal property was set at .122 (12.2 cents) per \$100.00 (one hundred dollars) with an anticipated revenues of \$1137.64.

This ordinance shall take effect on this 5th day of September, 2019.
