## Regular City Commissioner Meeting Minutes, Crab Orchard City Hall July 11, 2019

The meeting was called to order at 6:30 by Mayor Billy R. Shelton; Mayor Shelton led the invocation and led everyone in reciting the Pledge of Allegiance to the US Flag.

Role call was performed by City Clerk; all were present for meeting, Mayor Shelton established there was a quorum.

Last month's meetings minutes were reviewed and no changes needed to be made, Commissioner Kenneth Manuel made the motion to accept last month's minutes as stand, 2<sup>nd</sup> by Commissioner Keith Saylor, all in favor, motion carried.

Financial report was given by City Clerk (see attached), no changes need to be made, and Commissioner Kenneth Manuel, made the motion to accept as stand, 2<sup>nd</sup> by Commissioner Mike Eldridge, all in favor, motion carried.

#### Commissioner Reports:

Emergency Service Commissioner Kenneth Manuel reported Police Chiefs, Jimmy Gipson's report (see attached). 2 warning tickets, 4 complaints, 1 investigation, 2 arrests made both on drug related, 2 domestic calls and 4 traffic stops.

Water/Wastewater Commissioner Keith Saylor reported the water loss is 18%, he also reported Water Superintendent's Devon Shelton's monthly water report (see attached). We repaired 3 leaks, C.I. Thornburg will be here Tuesday to replace the check valves at lift station, Rick Cole will have someone to test the pumps. We need to research having a pulley system fabricated to pull the pumps from the lift station.

Streets and Road Commissioner Mike Eldridge reported, he has contacted Kentucky Utilities to install two more street lights in town one on Meadowlark Drive and the other at the corner of the Dollar General Store at the intersection.

The town branch area in front of Netha Hoskins's residence needs to have a replacement fence on the sidewalk area to block and public access from being able to slip and fall. Received a complaint from a business owner on the Lancaster Street business regarding the lack of parking due to the fact of the carports installed in the area.

City Commissioner Bill Dyehouse requested that invoice for the mulching from Pingleton Lawn Care to be itemized and broke down before payment is made.

We will have John Hackley to see if the city can obtain the Mary Murphy lot on Cherry Street.

Old Business: The new mower cost will be split 3 ways between the City, Water and Sewer. Brodhead Farm Mart has an E-Mark for \$4000.00 and they will service the mower there. The water tower, lift station and sewer plant will need to be mowed with this mower.

New Business: The Kubota side-by-side needs tires, Commissioner Dyehouse agreed to spit with the City and Water. We will get quotes from Wildcat Garage, Parts City and Dyehouse Farm.

# Crab Orchard Water & Wastewater Dept. Report for Monthly Meeting July 7 2019

## **Leaks and Repairs**

Repair water meter in front of Massage place. Installed a new box, lid, meter, valve and setter. Took old service out had a small leak at the cutoff valve.

Fix leak at Ricky Cummins'. ¾ inch line had cut in it. Replace 20 feet on line and installed new box, lid, meter, setter and valve.

Fix leak at Steve Crouch's. ¾ inch line running alongside the highway had a 1 inch long cut in the bottom. Repaired line with ¾ inch repair band.

Install new meter tap for the new house built on West Maple. Set a new ¾ in meter and setter on 2 inch main running along the edge of the road.

Repair meter on Rigsby Rd. Valve to meter would not shut off completely and the meter register was stuck. The customer had leak under his new rental property and could not shut water off. Replaced meter, box, lid, setter and shut off valve. Inside the old water meter was a small round white disk that was lodged to keep valve from shutting off.

Removed suction hose from bypass pump. Suction end became heavily clogged with rags and debris from sewer line.
