Meeting Minutes

Regular City Commissioner Meeting Minutes Crab Orchard City Hall Feb 6, 2020 6:30 pm

The meeting was called to order at 6:34 by Mayor Billy R. Shelton; Mayor Shelton led the invocation and led everyone in reciting the Pledge of Allegiance to the US Flag.

Role call was performed by City Clerk; all were present for meeting, Mayor Shelton established there was a quorum.

Last month's meetings minutes were reviewed and no changes needed to be made, Commissioner Bill Dyehouse made the motion to accept last month's minutes as stand, 2nd by Commissioner Keith Saylor, all in favor, motion carried.

Financial report was given by City Clerk (see attached), no changes need to be made, and Commissioner Keith Saylor, made the motion to accept as stand, 2nd by Commissioner Kenny Manuel, all in favor, motion carried.

Commissioner Reports

Emergency Service Commissioner Kenneth Manuel reported Police Chiefs, Jimmy Gipson's report (see attached). 5 complaints, 6 investigations, 13 arrest made, 5 traffic stops, 3 traffic citations, and 1 domestic. Reported very pleased with the lettering on the new Police SUV vehicle. Would like to keep possession of the old Ford Crown Vic Police Cruiser in case we can get a future grant for an additional part time police officer.

Water/Wastewater Commissioner Keith Saylor reported the water loss is 12.3% which is very good. We are working with contractor Charles Isaacs repairing man holes to try to eliminate additional I and I going directly into the sewer which contributes to the excess water in the sewer.

Streets and Road Commissioner Mike Eldridge stated he is still looking into purchasing a new dump truck. Have two to go and review one in Richmond and another one at Tommy Owens.

City Commissioner, Bill Dyehouse discussed the request from the CEO of the Lincoln County SPCA wanting the City of Crab Orchard to adopt and pass a city ordinance that would protect animals from cruelty and abuse. The commissioners decided since there already is a KRS against the animal cruelty there was not a need for an individual one in Crab Orchard.

Dale Shepherdson from AGE attended meeting to present the survey results of the Howard Theater. It has been determined that the parking lot belongs with the house and Theatre property. There have been several issues trying to locate the actual boundaries.

New Business:

Fire Chief Larry Owsley stated we received a grant of \$3200.00 for thermal imaging cameras.

City Clerk will mail out letter to all sewer customers explaining the new \$10.00 sewer surcharge to be added to the bill.

Will speak with Donna Waldrip at Casey County Bank regarding the status of the loan.

Steve Beachy has shown interest in either selling or trading the lot he owns beside the Veterans Park for the small area the City owns behind his apartments.

Honorable Mayor Sir, My name is Robert Todd, I'm the CEO of the Lincoln County Kentucky SPCA. (Society for the Prevention of Cruelty to Animals) a 501© 3 non profit registered with the Secretary of State in Good standing. IRS EIN 83-2174607 It is My duty and responsibility as CEO, to protect the animals in Lincoln County from Cruelty, Abuse, Neglect ,Abandonment, Torture, Hoarding etc. I have received numerous animal cruelty complaints within the City limits of Crab Orchard. I have personally witnessed cruelty, neglect, and hoarding while doing animal welfare checks in Crab Orchard. It is my understanding Crab Orchard does not have animal cruelty ordinances in place. If the City would put in place ordinances such as those in Stanford which could be used as a guide, The City could fine those violating the ordinances and provide animal protection and create extra revenue for the City.

Animal Cruelty which is a class B misdemeanor and a \$250 fine for first offense. I have witnessed up to 50 of these offenses while doing animal welfare checks in the City. 50x250=12,500 I'm sure they are many more. These extra funds would allow the City to provide extra patrols, services to the residents of Crab Orchard. The City could appoint the SPCA to enforce the ordnances at no cost to the City. I have the following certification from the ASPCA, United States Humane Society, Department of Justice. Animal Cruelty and Abuse for Law Enforcement-Investigating Animal cruelty and Abuse-Combating Dogfighting Animal Husbandry- Investigating and Court reporting- Field Emergency Response-Field Supervisor.
