Regular City Commissioner Meeting Minutes, Crab Orchard City Hall Jan 2, 2020 6:30 pm

The meeting was called to order at 6:30 by Mayor Billy R. Shelton; Mayor Shelton led the invocation and led everyone in reciting the Pledge of Allegiance to the US Flag.

Role call was performed by City Clerk; all were present for meeting, Mayor Shelton established there was a quorum.

Last month's meetings minutes were reviewed and no changes needed to be made, Commissioner Bill Dyehouse made the motion to accept last month's minutes as stand, 2nd by Commissioner Mike Eldridge, all in favor, motion carried.

City Commissioner, Bill Dyehouse raised the question regarding the Mary Murphy lot and if we had obtained it. He stated he would like to see about getting a stage constructed. Also wanted to know is there were any updates with the Howard Theatre survey from AGE, nothing has been updated. City Clerk has called and left message and haven't heard a response.

Old Business:

Renewal of the Air Evac contract is for the amount of \$4369.00 per year, Commissioner Kenny Manuel made the motion to renew the Air Evac contract, 2nd by Commissioner Keith Saylor all in favor motion carried.
