Meeting Minutes

Regular City Commissioner Meeting Minutes Crab Orchard City Hall Oct 1, 2020 6:30 pm

The meeting was called to order at 6:35 by Mayor Billy R. Shelton, Commissioner Bill Dyehouse led the invocation and Mayor Shelton led the pledge of allegiance to the US flag.

Role call was performed by City Clerk; all were present for meeting Mayor Shelton established there was a quorum.

Luther Galloway was present to discuss the storm water situation on the East side of town to include Elm Street, Maple and Sycamore. He presented to the board the options and Commissioner Bill Dyehouse made the motion to continue with the project and procure and engineering firm to install storm water system which could be 300-500K, 2nd by Commissioner Mike Eldridge all in favor motion carried.

Bid to sell the water and wastewater system to Ky. American Water was accepted and Commissioner Kenneth Manuel made to motion to accept the bid of 2 million dollars to sell both water and wastewater to Ky. American Water, 2nd by Commissioner Keith Saylor all in favor motion carried.

Commissioner Reports:

Emergency Service Commissioner Kenneth Manuel reported Police Chiefs, Jimmy Gipson's report (see attached). 3 warning tickets, 4 complaints, 2 investigations, 5 arrest made, 1 domestics and 5 traffic stops.

Water/Wastewater Commissioner Keith Saylor reported the installation of the new pump wasn't successful The pump had the impellers changed and when it was dropped back in the lift station it operated approximately 24-36 hours then it clogged back up.

Streets and Road Commissioner Mike Eldridge still waiting to hear from Dustin Harmon when he can start the blacktop for the street repair. There's a tree in front of Tommy Day that is growing in the sidewalk and will need to be cut down. Will call Preston Hubble to get an estimate. Also will contact Tony Morgan to get quotes for sidewalk repair around the city.

City Commissioner Bill Dyehouse stated Ann Giles with the Clinic want to purchase the Mary Murphy Lot and she wants to purchase it for \$8000.00 and pay \$2000.00 down and set the remaining on 6 months payments. We will enter into purchase agreement with her. The old bus on the lot across from the Pat Time Café still needs to be moved. Commented on ow good of a job Darrell Brummett is doing and how well things are looking.
