Meeting Minutes

Regular City Commissioner Meeting Minutes Crab Orchard City Hall April 1, 2021 6:30 pm

The meeting was called to order at 6:35 by Mayor Billy R. Shelton, Mayor Shelton, led the invocation and led the pledge of allegiance to the US flag.

Role call was performed by City Clerk; Commissioner Bill Dyehouse was absent. Mayor Shelton established there was a quorum.

March 2021 meetings minutes were reviewed and no changes needed to be made, Commissioner Kenneth Manuel made the motion to accept last month's minutes as stand, 2nd by Commissioner Jerry Shelton, all in favor, motion carried.

Financial report was given by City Clerk (see attached), no changes need to be made, and Commissioner Kenneth Manuel made the motion to accept as stand, 2nd by Commissioner Jerry Shelton, all in favor, motion carried.

Commissioner Reports:

Emergency Service Commissioner Kenneth Manuel reported Police Chiefs, Jimmy Gipson's monthly report (see attached). Warning tickets 0, Complaints 6, Investigations 3, Citations 10, Domestics 2, Accidents 0, Traffic Stops 13, Case Reports 2, Arrest Made 8, Misdemeanors 5 and 3 Felony.

Streets and Road Commissioner Jerry Shelton stated he has spoken with the State Road department and in order for us to name that portion of Hwy 150 the Bradley Turner Hwy the City would have to adopt a resolution and send to the road department. The city will also have to pay for the signage, we would also have to speak with Judge Adams regarding the fact that the road has also been named as the Neal James Highway.

Streets and Road Commissioner Jerry Shelton stated he has spoken with the engineer regarding the Storm water project. He has spoken with the county and they have agreed to furnish some rock to repair the ditch lines, the lot the city owns on Walnut the culvert needs to be replaced. Anna Mae Hopkins has reported the water from the cemetery is flooding her culvert. There needs to be a diversion of concrete poured to divert the water from the cemetery.

Water/Wastewater Commissioner Rick Spoonamore reported he has spoken to Jeff Lee and there is another small leak that will need to be located and repaired.

New Business:

Commissioner Jerry Shelton made the motion to Adopt resolution 2021-04-01 Bradley Turner Highway between the portions on Hwy 150 to start at Hwy 2750 and end at Hey 39S, 2nd by Rick Spoonamore all in favor motion carried.

The new sidewalk will need to be handicap accessible and the driveways will need to possibly blacktopped, also the ditch in front of the Ambulance Building needs to be extended with guides and would like to black top behind the Ambulance Building to the street.

Resident Mike Carpenter stated he wanted his yard repaired where the sidewalk was installed. Commissioner Jerry Shelton stated he would go and look at it.

He understands he can't permanently live in the camper and there is a one year time frame to remove the old trailer and replace with new one.
