Meeting Minutes

Regular City Commissioner Meeting Minutes Crab Orchard City Hall July 8, 2021 6:30 pm

The meeting was called to order at 6:37 by Mayor Billy R. Shelton, Mayor Billy R. Shelton led the invocation and Mayor Shelton led the pledge of allegiance to the US flag.

Role call was performed by City Clerk; all were present, Mayor Shelton established there was a quorum.

June 2021 meetings minutes were reviewed and no changes needed to be made, Commissioner Jerry Shelton made the motion to accept last month's minutes as stand, 2nd by Commissioner Rick Spoonamore, all in favor, motion carried.

Financial report was given by City Clerk (see attached), no changes need to be made, and Commissioner Kenneth Manuel made the motion to accept as stand, 2nd by Commissioner Jerry Shelton, all in favor, motion carried.

Commissioner Reports:

Emergency Service Commissioner Kenneth Manuel reported Police Chiefs, Jimmy Gipson's monthly report (see attached). Warning tickets 0, Complaints 6, Investigations 2, Citations 4, Domestics 1, Accidents 0, Traffic Stops 5, Case Reports 2, Arrest Made 10.

Streets and Road Commissioner Jerry Shelton stated he met with State Road Engineer regarding the drainage issue on front of Wildcat Towing. The grade was shot every 10 feet and there is a hump in the middle of the road. One possibility is too mill the road down and make a trench for the water to run down to drain properly. The street actually needs to be re-blacktopped.

Discussed the purchasing of a bucket for the backhoe, nothing was finalized. The measurement of the sidewalk from Manor to Walnut is approximately 1300 feet and the first phase from the corner of Hickory to Manor also measured out at 1300 ft approximately. Therefore the remainder should be close to the same cost as the previous.

Also discussed placing a sidewalk between the Dollar Store and Parts City parking lot, in order for the handicap to travel to the Dollar Store little safer.

Water/Wastewater Commissioner Rick Spoonamore stated the sidewalk at Walnut Street is uneven and should be check at the corner. The limbs on two properties on Main Street are over the sidewalk and needs to be trimmed. Also there seems to be water standing in front of Clara Wyler's house, will tell Darrell to check it out.

New Business:

Reviewed quote for security system and Commissioner Kenney Manuel made the motion to accept the bid for \$10,998, 2nd by Commissioner Jerry Shelton all in favor, motion carried.
