The meeting was called to order at 6:35 by Mayor Billy R. Shelton, Commissioner Bill Dyehouse led the invocation and Mayor Billy R. Shelton led the pledge of allegiance to the US flag.

Role call was performed by City Clerk; all was present except, Mayor Shelton established there was a quorum.

Oct 21, 2021 meetings minutes were reviewed no changes were needed, Commissioner Bill Dyehouse made the motion to accept the minutes as stand, 2nd by Commissioner Rick Spoonamore all in favor, motion carried.

Financial report was given by City Clerk (see attached), no changes need to be made, and Commissioner Kenneth Manuel made the motion to accept as stand, 2nd by Commissioner Bill Dyehouse, all in favor, motion carried.

Commissioner Reports:

Emergency Service Commissioner Kenneth Manuel reported that he has received complaints regarding the pit bull dog on Walnut Street and Police Chief Gipson has investigated that complaint several times and discussed with the owner about keeping the dog restrained. Commissioner Kenneth Manuel also reported Police Chiefs, Jimmy Gipson's monthly report (see attached). Warning tickets 1, Complaints 4, Investigations 3, Citations 1, Domestic 2, Accidents 0, Traffic Stops 6, Case Reports 0, 1 open, 0 closed and Arrest Made 1, 1 Misdemeanor and 0 Felony.

Water/Wastewater Commissioner Rick Spoonamore reported e have repaired some water leaks. Also Lancaster water reported they will have the master water meter tested Oct 13th to see if the meter if the meter is operating accurately.

Streets and Road Commissioner Jerry Shelton, reported all bills have been paid up to date for the sidewalks. There's some piles of dirt left that will need to be moved, will get the water employees to do so. Will need to do some touch up work as well. Will need to possibly do some ditch work on the new homes on Sycamore Street to drain away from the houses. Property on Walnut street that city owns will need a new culvert installed.

City Commissioner Bill Dyehouse questioned if Clara Wyler had been contacted regarding the trees left over behind her stores and the new owner of the Theatre, Kevin Bullock has also been trying to contact the tree service that had cut the trees down. He has been given Wildcat Towing's information as he stated he would clean up and move the tree and debris. Also wanted to know what decorations will be needed for Christmas and to purchase whatever was necessary.

New Business;

Mayor requested the Planning and Zoning to be reviewed and to maybe allow for single wide trailers to be allowed inside city limits as long as they met certain restrictions that the city commission had set forth.




No further business to discuss,
