Meeting Minutes

Regular City Commissioner Meeting Minutes October 21, 2021 6:30 pm

The meeting was called to order at 6:33 by Mayor Billy R. Shelton, Mayor Shelton led the invocation and the pledge of allegiance to the US flag.

Role call was performed by City Clerk; all was present except, Commissioner Bill Dyeshoue was absent, Mayor Shelton established there was a quorum.

Sept 2 2021 meetings minutes were reviewed no changes were needed, Commissioner Kenneth Manuel made the motion to accept the minutes as stand, 2nd by Commissioner Jerry Shelton all in favor, motion carried.

Financial report was given by City Clerk (see attached), no changes need to be made, and Commissioner Jerry Shelton made the motion to accept as stand, 2nd by Commissioner Rick Spoonamore, all in favor, motion carried.

Commissioner Reports:

Emergency Service Commissioner Kenneth Manuel reported Police Chiefs, Jimmy Gipson's monthly report (see attached). Warning tickets 10, Complaints 6, Investigations 4, Citations 3, Domestics 2, Accidents 1, Traffic Stops 5, Case Reports 0, 0 open, 3 closed and Arrest Made 5, 4 Misdemeanor and 1 Felony.

Commissioner Kenneth Manuel also stated they are closing out the remaining balance of the East End Ambulance checking account and will need to verify who owns the property and if East End owns the property the they will need to donate to the City of Crab Orchard and Crab Orchard lease to the Lincoln EMS for \$1.00 per year for use. There is approximately 9K left in the account. Commissioner Manuel also stated he has received complaint on the pit bull dog the owner resides on Walnut Street.

Streets and Road Commissioner Jerry Shelton, reported they had distributed 254K to the Lincoln EMS. The sidewalk project had been completed and Crouch and Stringer was the first company that could get the project finished quicker. They still have some fill work to do once the dirt has settled. They are billing for the labor only and the materials will be billed to the City of Crab Orchard for payment. The concrete approximately will be \$9200, rock \$1200, and Steel \$1500.

Water/Wastewater Commissioner Rick Spoonamore questioned why the water bill is so high? Also Rick Spoonamore made the motion to hire Eric Derringer as full time water/sewer employee starting out at \$13.00 per hour 2nd by Commissioner Kenneth Manuel all in favor motion carried. We only had one person to put application in for the meter reader position and due to our Ethics Ordinance, section on Nepotism we cannot employee any family members. We will not hire anyone at this time.

City Commissioner Bill Dyehouse absent nothing to report.

New Business:

Commissioner Kenneth Manuel made the motion to adopt resolution to Establish Essential Employees for the Arpa funds pay, 2nd by Jerry Shelton all in favor motion carried.

Commissioner Jerry Shelton made the motion to pay the Essential Employees \$2.00 per hours worked between March 1 2020 and March 1 2021 using the ARPA funds, 2nd by Commissioner Kenneth Manuel all in favor motion carried.

RESOLUTION 2021-10-14

Declaration of Essential Employees

WHEREAS, former US. President Donald Trump's Coronavirus Guidance for America, as defined by the Department of Homeland Security, below classifies certain work as essential with a responsibility to maintain your normal work schedule; and

WHEREAS, likewise, Kentucky Governor Andy Beshear ordered all nonessential businesses to close and telework but this Order ha exempted essential local government workers involved in public safety, Public Worlds, and other community-based government operations; and

FURTHERMORE, in accordance with the President's mandate and in collaboration with other federal agencies and the private sector, the Cybersecurity and Infrastructure Security Agency (CISA) of the U.S. Department of Homeland Security (DHS) developed a list of "Essential Critical Infrastructure Workers" that identified as essential the following categories of city and local government workers:

- Personnel in Emergency Management, Law enforcement, Emergency Management Systems, Fire and Corrections, including from line management;
- Workers supporting communication systems and information technology used by law enforcement, public safety, medical, energy or other critical industries;
- Support, such as road and line clearing, to ensure the availability of needed facilities, transportation, energy and communications;
- Support to ensure the effective removal, storage and disposal of residential and commercial solid waste and hazardous waste;
- Customer service and support staff, including managed and professional serviced as well as remote
 providers of support to transitioning employees to set up and maintain home offices, who interface with
 customers to manage or support service environments and security issues, including payroll, billing,
 fraud and troubleshooting;
- Federal, State and Local, Tribal and territorial employees who support Mission Essential Functions and communications networks;
- Workers that maintain digital systems infrastructure supporting other critical government operations,
- Workers at operations centers necessary to maintain other essential functions;
- Workers who are needed to process and maintain systems for processing financial transactions and services (e.g., payment, clearing and settlement; wholesale funding; insurance services, and capital markets activities);

And,

WHEREAS, all employees of the City of Crab Orchard are necessary to maintain proper operations of local government, which has been designated as part of pour nations critical infrastructure; and all employees maintain regular and frequent contact with the public and/or have frequent contact by touching items that are sent and received through regular channels of public contact;

NOW, THEREFORE, I Billy R. Shelton, Mayor of the City of Crab Orchard, KY, and Commissioners, Bill Dyehouse, Rick Spoonamore, Jerry Shelton and Kenneth Manuel do hereby declare all employees of the City of Crab Orchard, Kentucky as essential. This order shall be effective retroactively to coincide with the Declaration of a State of Emergency issued on March 17, 2020.
