BE IT ORDAINED BY THE CITY OF CRAB ORCHARD, KENTUCKY:

AN ORDINANCE OF THE CITY OF CRAB ORCHARD, KENTUCKY FIXING AND ESTABLISHING THE ANNUAL SALARY AND COMPENSATION FOR THE ELECTED OFFICE OF MAYOR OF THE CITY OF CRAB ORCHARD AND FOR THE ELECTED OFFICE OF COMMISSIONERS OF THE CITY OF CRAB ORCHARD FOR THE TERM OF OFFICE BEGINNING IN JANUARY 2023.

WHEREAS, the City of Crab Orchard and environs have and are experiencing continuing growth which requires the city's mayor and the city's commissioners to expend increasing time and effort to discharge the duties and responsibilities of office and to attend to the business and needs of the city, all for which the said mayor and commissioners should receive an adequate and reasonable salary and compensation; and

WHEREAS, the City Commissioners of the City of Crab Orchard has so determined that the salary and compensation now payable to and received by the city's mayor and the city commissioners which should be increased for the next elective term of office beginning in January of 2023, and hereby so provides for and fixed such new and said salary and compensation for the elective office of Mayor of the City of Crab Orchard, and for the elected office of Commissioner of the City of Crab Orchard, Kentucky, as hereinafter provided, and

NOW, THERFORE, BE IT ORDAINED BUT THE CITY COMMISSION OF THE CITY OF CRAB ORCHARD, KENTUCKY AS FOLLOWS:

SECTION I: REPEAL OF FORMER ORDINANCES

Any prior ordinance of the City of Crab Orchard, Ky, that contradicts the following is hereby repealed.

SECTION II: SALARY AND COMPENSATION FOR MAYOR

Pursuant to KRS 83A.070(1) and KRS 83A.075(2), the annual salary and compensation for the elected office of Mayor of the City of Crab Orchard, Kentucky, is currently established at and/or re-established at the sum and amount of FOUR HUNDRED (\$400.00) monthly for next elective term of office beginning January 2023.

SECTION III: SALARY AND COMPENSATION FOR COMMISSIONER

Pursuant to KRS 83A.070(1) and KRS 83A.075(2), the annual salary and compensation for the elected office of Commissioner of the City of Crab Orchard, Kentucky, is currently established at and/or re-established at the sum and amount of FOUR HUNDRED (\$400.00) monthly for next elective term of office beginning January 2023.

This Ordinance shall become effective on the 2^{ND} day of May, 2022 after its 2^{nd} reading and upon Publication.
