The meeting was called to order at 6:30 by Mayor Jesse Harris, Commissioner Bill Dyehouse led the invocation and Mayor Harris led the pledge of allegiance to the US flag.

Role call was performed by City Clerk, all was present, and Mayor Harris established there was a quorum.

March 2, 2023, meetings minutes were reviewed no changes were needed, Commissioner Jerry Shelton made the motion to accept the minutes as presented, 2nd by Commissioner Kenneth Manuel all in favor, motion carried.

Financial report was given by City Clerk (see attached), No changes needed to be made, Commissioner Bill Dyehouse made the motion to accept the financials, 2nd by Commissioner Kenneth Manuel, all in favor motion carried.

Commissioner Reports:

Emergency Services Commissioner Kenneth Manuel presented Police Chiefs Jimmy Gipson's monthly report (see attached), 8 complaints, 4 investigations, 4 theft investigation, 2 citations, 2 domestics, 9 traffic stops, 2 criminal summons served, Arrest made 1 misdemeanor, caser reports 2 open. Sent out 6 nuisance violations.

Water/Wastewater Commissioner Mike Eldridge reported the water loss is at 42.7% and the Harris lift station will need the ground area around it to be filled back with some dirt, due to the previous repairs.

Streets and Roads Commissioner Jerry Shelton stated the side walk in front of the old Ayers property will need to be repaired where the trees were removed from the demolition of the house. He checked the flooding issue between the McNicholas and Simpson house on Lancaster St and where Mr. McNicholas has installed a culvert is forcing the water over on the Simpsons property and the culvert in the ditch line is stopped up.

City Commissioner Bill Dyehouse reported he has had 4 contractors to look at the stage project to bid, but still no bids have been received thus far.


