The meeting was called to order at 6:32 by Mayor Jesse Harris, Commissioner Bill Dyehouse led the invocation and Mayor Harris led the pledge of allegiance to the US flag.

Role call was performed by City Clerk, all were present, and Mayor Harris established there was a quorum.

Commissioner Reports:

Water/Wastewater Commissioner Mike Eldridge reported water loss is at 8.4% which is questionable.

Resident on Elm Street is starting to gather quite a bit of stuff and items at his house, will need to either send him letter or someone to speak with him,

Fire Chief Larry Owsley reported had a fire in the cab of firetruck due to the AC unit locked up and caught fire during the 4th of July Parade.

City of Crab Orchard Ordinance #23-06-02 Water/Wastewater Rate Ordinance

BE IT ORDAINED BY THE CITY OF CRAB ORCHARD, KENTUCKY:

WHEREAS, it is necessary for the City of Crab Orchard, Kentucky to increase water, and refuse rate due to the rise in raw water cost, the new water lines, refuse service and operating and maintenance costs: the City of Crab Orchard, Kentucky does hereby amend the rates presently being charged.
