## Meeting Agenda

Regular Commissioner Meeting, Crab Orchard City Hall November 2, 2023 6:30 pm

The meeting was called to order at 6:30 by Mayor Jesse Harris, Commissioner Bill Dyehouse led the invocation and Mayor Jesse Harris led the pledge of allegiance to the US flag.

Role call was performed by City Clerk, all were present, Mayor Jesse Harris established there was a quorum.

October 5, 2023 meetings minutes were reviewed no changes were needed, Commissioner Bill Dyehouse made the motion to accept the minutes as presented, 2<sup>nd</sup> by Commissioner Mike Eldridge all in favor, motion carried.

Financial report was given by City Clerk (see attached), No changes needed to be made, Commissioner Mike Eldridge made the motion to accept the financials, 2<sup>nd</sup> by Commissioner Kenneth Manuel, all in favor motion carried.

Dan Kaelin with Strand Engineering presented to the board the different options and stated the surveying had been completed. The board discussed and decided to choose option 1 of the storm water projects. The vote was Option 1, Mike Eldridge, Jesse Harris, and Bill Dyehouse. Jerry Shelton and Kenny Manuel voted against option 1.

# Commissioner Reports

City Commissioner, Bill Dyehouse reported that he will attend the Fiscal Court and request for reimbursement for the paving of Cedar and Chestnut Street. Spoke with the Judge and he stated he felt like 13k was a doable amount.

The church is placing a large cross on the state easement beside the new Family Dollar Tree area and they stated they would help fund if needed.

Water/Wastewater Commissioner, Mike Eldridge reported increase in water loss, it was 34%. Also discussed that would like to use the next round of funds from the KIA for Radio Read meters, it would be more accurate and just overall better.

Streets and Roads Commissioner, Jerry Shelton reported Chestnut quote to black top was 19,700. Jerry Shelton made the motion to accept the quote for Sowers to blacktop Chestnut Street, 2<sup>nd</sup> by Kenneth Manuel all in favor motion carried. Several other streets are in need of blacktopping as well, Cedar Street in particular. The Simpsons home where the replacement of the culvert work was complete the cleanup work needs to be finished.

Emergency Services Commissioner, Kenneth Manuel reported Police Chiefs Jimmy Gipson report, (see attached) issues 2 city violations, 12 complaints, 2 investigations, 2 misdemeanors, 0 felonies, 3 drug investigations, 6 theft investigation, 3 burglary, 2 citations, 2 domestic and 14 traffic stops. Received complaint of Kathy Shafer's dog chasing children of the street and sidewalk. Also the Howard Theatre is in dire need to repair and could be considered a death trap, need to seen owner letter to determine the safety of the existing building.

Commissioner Bill Dyehouse made the motion to accept the reading of 23-12-07 increase the refuse rate \$.60 across all categories, 2<sup>nd</sup> by Commissioner Mike Eldridge, all I favor motion carried.

Commissioner Mike Eldridge made the motion to accept quote \$1590.00 for both Police Chief and the Seer Plant, 2<sup>nd</sup> by Commissioner Kenneth Manuel all in favor motion carried,

Commissioner Bill Dyehouse made the motion to increase the city clerks salary by \$2.00 per hour since she hadn't had a raise in 4 years, 2<sup>nd</sup> by Commissioner Mike Eldridge, vote yeas Bill Dyehouse, Mike Eldridge, Kenneth Manuel, nae, Jesse Harris and Jerry Shelton abstained. Motion passed

### **Ordinance 23-11-02**

Sidewalk Ordinance and Policy

Wherefore, the City of Crab Orchard desires to establish procedures for sidewalk maintenance and repair and safety within the city limits, and to accomplish that goal the City proposes to Ordain the hereinafter provisions:

Now Therefore, the Be It Hereby Ordained by the City of Crab Orchard, Kentucky:

I. Sidewalk Repair(s) Policy

It shall be the duty of the city to assume the duty to make emergency repairs to sidewalks according to the following policy:

- (A) The city shall budget approximately \$3,000 per year for emergency sidewalk repairs. or such other amount as the City deems necessary, thereafter, annually; and,
- (B) The city shall repair sidewalks which have become genuinely hazardous to pedestrians by reason of their disrepair.
- (C) The repair or replacement of sidewalks which are not in a hazardous condition shall be the responsibility of the adjacent property owner, but such repair or reconstruction shall be done according to city specifications.
  - (D) This policy applies only to sidewalks within the boundaries of city rights-of-way and

the repair or replacement of all sidewalks on private property shall be the responsibility of the property owner.

2. Dirt, Debris, Grass and Weed Growth; Snow and Ice Deposits

(A) It shall be the duty of the owner or occupants of property or lots abutting on sidewalks to keep the sidewalks in front of their property or lots clean and free from rubbish and dirt, whether they are washed by water flooding the sidewalks or from any other source. The property owner is also responsible for maintaining the weed growth and keeping clear the area around the sidewalk, to include ditch lines from sidewalk to street. Should filth accumulate on the sidewalks of the city and the owner or occupant of the lot abutting the sidewalk at such place or places fail to remove the filth, it shall be the duty of the City to notify the owner in writing, setting forth the objectionable condition of the sidewalk. If the owner or occupants fail to remove the dirt, filth or maintain weed growth within three days from the date of notice, he or they shall be fined as provided in HB422 nuisance ordinance 20-12-03

(B) It shall be the duty of the person occupying the property in front of which there is a permanent pavement of wood, concrete, brick or other paving material, to keep the same free of snow, ice or other dangerous covering or obstruction. If the owner or occupants fail to remove the snow, ice or within three 24 hours from the date of notice, he, she or they shall be fined as provided in HB422 nuisance ordinance 20-12-03

This Ordinance shall become effective on the \_\_\_\_\_ day of Nov, 2023 after its 2<sup>nd</sup>

reading passage and upon publication.
