The meeting was called to order at 6:30 by Mayor Jesse Harris, Mayor Harris led the invocation and the pledge of allegiance to the US flag.

Role call was performed by City Clerk, all were present, Mayor Harris established there was a quorum.

September 5, 2024 meetings minutes were reviewed. No changes needed to be made, Commissioner Keith Saylor made the motion to accept the minutes as presented, 2nd by Commissioner Mike Eldridge, all in favor, motion carried.

Financial report was given by City Clerk (see attached), No changes needed to be made, Commissioner Kenneth Manuel made the motion to accept the financials, 2nd by Commissioner Keith Saylor, all in favor motion carried.

Linda Dyehouse asked to speak to the commission, she expressed her sincere thanks for everything the city did in the passing of Bill. She was honored that we asked her to fill Bill's remainder of his term, but she knew that she wouldn't be able to do so. She also expressed her approval for the appointment of Keith Saylor to serve the remainder of the Bill's term.

Commissioner Reports

City Commissioner Keith Saylor reported the city has purchased some new playground equipment; the stain has been purchased for the stage as soon as the prisoners can be available, we will get it stained. The city has collected to date approximately \$5200 in property taxes. The spooktacular festival is scheduled for Oct 26th, games, chili cook, face painting, pumpkin painting and karaoke.

Water/Wastewater Commissioner Mike Eldridge reported water loss is at 29%. Repaired leak at corner of 3246 and 39, replaced service line at Ernest Bennetts, replaced setter at Blankenship's, working on Lead and Copper surveys. Purchase side toolbox for the water truck.

Streets and Road Commissioner, Jerry Shelton stated the County Road Dept is to come and replace the culvert at Robbins property on Maple, they will provide the guardrail on West Maple. The culverts on Walnut Street are stopped up and will need to be cleaned out. Also, South Elm Street culverts needs to be cleaned out from the installation of the gas line.

Emergency Services Commissioner, Kenneth Manuel gave Police Chiefs report (see attached) issued 8 warning tickets 10 complaints, 1 investigation, 7 arrest made, 2 theft investigation, 0 burglary, 5 citations, 2 domestics and 8 traffic stops and 5 city violations sent out. Will need to look into purchasing a new cruiser. Both are getting some mileage and age on them and will need to purchase a new one soon.

Fire Chief Larry Owsley reported the fire dept is receiving at 10K grant from State Farm to assist in purchasing turn out gear.
