Special Called Commissioner Meeting, Crab Orchard City Hall July 11, 2024 6:30 pm

The meeting was called to order at 6:30 by Mayor Jesse Harris, Commissioner Bill Dyehouse led the invocation and Mayor Jesse Harris led the pledge of allegiance to the US flag.

Role call was performed by City Clerk, all were present, Mayor Harris established there was a quorum.

June 6, 2024 meetings minutes were reviewed. No changes needed to be made, Commissioner Bill Dyehouse made the motion to accept the minutes as presented, 2nd by Commissioner Kenneth Manuel, all in favor, motion carried.

Financial report was given by City Clerk (see attached), No changes needed to be made, Commissioner Kenneth Manuel made the motion to accept the financials, 2nd by Commissioner Mike Eldridge, all in favor motion carried.

Commissioner Reports:

City Commissioner Bill Dyehouse had a complaint about weeds growing on Garden Lane and the Martin's back yard. Also need to speak with Willie Ashley get him to clean up his property that he just purchased off of Elm Street, also Steven Beachy's pile of wood needs cleaned. Need to speak with the executor of Scott Colemans land as it needs to be bush hogged. The stage needs to be stained, need to have Jerry Shelton to check out the fans on the stage, the ditch line on Elm Street needs to be weed eaten and Darlene's ditch line on Walnut and the house at 146 Lancaster Street also needs to be mowed.

Water Wastewater Commissioner Mike Eldridge reported waste loss is at 19%, they have installed new water meter on Willow Lane. The water salesman amount has been changed to 25 gallons per \$.25 cents.

Streets and Road Commissioner Jerry Shelton questioned if we were receiving and payroll taxes from Martin Construction, still haven't been able to get the information on who need to send to with Martin. Kathy Shafer's house on Cherry Street that she has started tearing down need to find when she will complete the clean up. The County Comprehensive plan committee has met, and the last Comprehensive Plan was done in 2008. They have change two items added a residential R-3 multi family.
